CORRIGENDUM-I

Sub: “Supply Installation Testing and Commissioning of IP-MPLS at various metro stations in DMRC on back-to-back basis from RailTel Empanelled BAs and SIs”.

Ref: RailTel/EOI/NR/BA/21-22/Business-Delivery/RO/NTP/02 Dated: 08-05-2021.

1. Sub-Clause 7 of Clause 4b of Selection Criteria in the EOI document may be read as under:

“The BA/SI shall submit a notarized affidavit (as per annexure-3) on a nonjudicial stamp paper stating that they meet the 100% compliance requirements & all their statements/documents submitted along with the bid are true and factual. Standard format of the affidavit to be submitted by the bidder is given in the EOI document. Non submission of an affidavit by the bidder shall result in rejection of his/their bid and it shall be mandatorily incumbent upon the BA/SI to identify, state and submit the supporting documents duly self-attested by which they/he are/is qualifying the work experience/ Qualifying Criteria mentioned in the EOI Document. It will not be obligatory on the part of EOI Evaluation Committee to scrutinize beyond the submitted document of the BA/SI as far as his qualification for the EOI is concerned.

NOTE: In view of Lockdown/Curfew situation in various states due to Covid-19 Pandemic, bidders are also permitted to submit Annexure-3 on their Company’s Letter Head duly signed by the authorized representative. However, the successful bidder will have to submit the Annexure-3 on notarized stamp paper before awarding of the contract.

2. Clause 23.10 may be read as under:

“Power of attorney in favour of the signatory duly authorizing the signatory shall be submitted online to the tendering authority before the due date and time of submission of the e-Tender.

NOTE: In view of Lockdown/Curfew situation in various states due to Covid-19 Pandemic, bidders are also permitted to submit Power of Attorney on their Company’s Letter Head duly signed by the competent authority. However, the successful bidder will have to submit the same on notarized stamp paper before awarding of the contract.

3. Bid Submission and Opening timelines are revised as under:

All other terms and conditions will remain unchanged.
