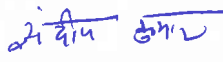

On completion of work and issue of the certificate of provisional acceptance of the entire system, the security deposit will be refunded to the contractor after adjustment of any dues payable by the contractor. On completion of Warranty period and on certification of concerned Railtel Engineer- in-charge for no defects for the entire supply, the security deposit will be refunded or released to the contractor after adjustment of any dues payable by the contractor. . CONTRACT PERFORMANCE GUARANTEE (PBG) 4.2 The Performance Guarantee should be furnished by the successful contractor after letter of acceptance has been issued, but before signing of the agreement. The agreement should normally be signed within 15(fifteen) days after issue of LOA and Performance Guarantee should also be submitted within this time limit. The Instruments for Performance Guarantee should be valid for two months beyond the warranty period (Clause 22 of SCC) (Page no:5 of 21) 4.3 Performance Guarantee shall be released after satisfactory completion of the work, and on expiry of the warranty period .The procedure for releasing should be same as for Security Deposit. (Page no:5 of 21)	4. CONTRACT PERFORMANCE GUARANTEE (PBG) 4.2 The Performance Guarantee should be furnished by the successful contractor after letter of acceptance has been issued, but before signing of the agreement. The agreement should normally be signed within 15(fifteen) days after issue of LOA and Performance Guarantee should also be submitted within this time limit. The Instruments for Performance Guarantee should be valid for two months beyond the Completion Period. (Page no:5 of 21) 4.3 Performance Guarantee shall be released after satisfactory completion of the work, and on certification of concerned Railtel Engineer- in-charge.
