1. The item/items in this tender should be quoted as per the Technical Specifications (Annexure-A).
2. The bidder should be either OEM or his authorized dealer/distributor/partner.
 - a. In case of the authorized dealer/distributor/partner MAF (Form-III) from the OEM to this effect should be submitted.
 - b. If OEM is quoting, then OEM should submit the self-certificate as OEM.
 - c. All bidders should fulfil all Technical & Financial Eligibility criteria.
3. Bidders are required to submit duly filled and signed technical compliance of the item offered in Annexure-A.
4. The bidder shall upload the clause-wise compliance to this Tender Document.

5. Technical Eligibility Criteria:

- a) The tenderer must have successfully completed any of the following during last 07 (seven) years, ending last day of month previous to the one in which tender is invited:

Three similar works each costing not less than the amount equal to 30% of advertised value of the tender, or

Two similar works each costing not less than the amount equal to 40% of advertised value of the tender, or

One similar work each costing not less than the amount equal to 60% of advertised value of the tender.

Offers not accompanied by copies of POs and work completion certificate (user certificate in the format of Form no.1) may be rejected.

- 6. Meaning of Similar Work:** Supply of Ducts.

7. Financial Eligibility Criteria:

The tenderer must have received contractual payments in the previous three financial years and the current financial year up to the date of inviting of tender, at least 150% of the advertised value of the tender. The tenderers shall submit Certificates to this effect which may be an attested Certificate from the concerned department / client or Audited Balance Sheet duly certified by the Chartered Accountant/Certificate from Chartered Accountant duly supported by Audited Balance Sheet.

(Note: Client certificate from other than Govt. Organization should be duly supported by Form 16A/26AS generated through TRACES of Income Tax Department of India).

- 8. Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for percentage of 25% of total value.
- 9. Earnest Money Deposit (EMD): Rs. 6,51,300/-** through payment online through RTGS / internet banking in Beneficiary name RailTel Corporation of India Limited Account No. 33946516594, IFSC Code SBIN0020299, Bank Name: State Bank of India, Branch address: Veer Chambers, Ranga Reddy District, Begumpet – 500016. The Bid received without EMD will be summarily rejected.

Note: Firms registered with UDYAM certification for the tendered item / work is exempted from submission of EMD. Firms claiming for the above exemptions under UDYAM certification have to submit supporting documents.

UDYAM Certificate with category as Traders are not eligible for EMD exemption.

10. Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Tender document, and Corrigendum if any.
11. **Inspection:** Pre-dispatch inspection by RailTel or as advised by RailTel Executive for 3rd party inspection like RDSO/RITES.
- i. The supplier/manufacturer shall send inspection call letter when the material is ready to be supplied and ready for inspection. The Inspection shall be carried out at supplier's /Manufacturer's premises by the Inspecting Authority.
 - ii. The supplier/manufacturer shall submit along with inspection call the details of test procedures, test programs, test parameters together with permitted values, etc., and their Quality Assurance Plan.
 - iii. In case material/equipment fails during inspection, the fresh lot of same material/ equipment shall be offered without any extra cost, by the manufacturer/supplier. In such a case, total cost of re-inspection including travel, lodging & boarding of the inspecting officials shall be borne by manufacturer's / supplier's account/cost.
 - iv. Inspection of the material including that of raw material if deemed required shall be conducted by approved Govt. inspecting authority/RailTel at the firm's premises/Govt. approved Test labs. The inspection shall be conducted by inspecting authority as per required test procedures /test plan for ensuring that the material offered meets the required specifications.
 - v. The inspection shall be done as per RDSO acceptance test format.
 - vi. For items/parameters of RDSO specification not covered in the acceptance test format, the firm has to provide documentary evidence to show the compliance with RDSO specification.
 - vii. HDPE Duct manufacturers are required to purchase raw material from RDSO approved sources or their authorized distributors/agents only. During bulk production also, the duct manufacturers shall use the same RDSO approved grade of Resin, which has been used during the manufacture of samples submitted for quality evaluation. It is the prime responsibility of the manufacturer to ensure that all inward goods are procured from approved sources or the authorized dealers of approved sources only. This item is applicable only to those firms who were included in the approved list of vendors before this item was decontrolled by RDSO. For other firms the raw material should be such that the RDSO specification requirements are met and documentary evidence to be provided.
 - viii. Random checks anywhere in the coil by cutting the duct will be made at site to ensure that ducts supplied are of correct dimensions/ thickness/composition.
 - ix. Inspection of the material will be done by RDSO/RITES. In case RDSO/RITES does not carry out inspection, the same will be done by RailTel's Authorized representative.
 - x. The Inspection shall be carried out by RailTel officials as per the specifications at OEM premises. The supplier shall make available for inspection all types of equipment in sufficient number so as to create test set up for carrying out various tests as per the approved test plan and test set up. Travelling, lodging, and boarding expenses of RailTel representative and charges for third party inspection if any shall be borne by RailTel, but necessary facilities to carry out test /witness inspection shall be provided by the manufacturer/supplier, free of cost.
 - xi. The manufacturer shall maintain stock register (receipt, issue and balance) and defect records for the raw material. The defect records shall be in standard formats, and it shall be compiled on a daily/ weekly/ monthly basis, and it shall be analyzed. "NIL" Report shall be segregated from the accepted material. First-in First-out concept shall be implemented in fool proof manner. The batches of the raw material shall be identified and traceable. All relevant documents necessary to ensure traceability shall be maintained. The raw material shall be protected from direct exposure to sunlight, moisture, water ingress and heat etc.
 - xii. Finished products shall be tested 100% by the factory QC personnel before being offered to RailTel for acceptance to ensure that it meets all quality requirements as per the relevant specifications. Duly filled in test

formats indicating the results of such tests shall be submitted along with material offered for inspection to RailTel.

- xiii.** RailTel reserves the right to cancel pre dispatch inspection and opt for consignee inspection after receipt of material.
- 12. Warranty:** The materials are to be warranted for **18 months** from date of receipt and acceptance of material by consignee.
- 13. Completion Period of Work:** The work should be complete within **90 days** from the date of issue of LOA/PO.
- 14. Schedule of Requirements:** As per Annexure-A.
- 15. Consignee Details:** As per Annexure-B.
- 16. Offer Validity:** **60 days** from the date of opening of tender.

- 18. Security deposit (SD)/PBG:** The successful tenderer shall submit **5%** of total value of the stores/works detailed in the Acceptance Offer towards security deposit in the form of **DD/FDR or irrevocable Bank Guarantee** from any scheduled bank for due fulfilment of contract. The instrument shall be **valid for three months beyond the warranty period**. The security deposit shall be released after successful completion of contract including warranty period, duly adjusting any dues recoverable from the successful tenderer. Payment of Security Deposit in the form of Pay Order/Demand Draft should be made in favour of **“RailTel Corporation of India Ltd”** payable at Secunderabad only, within 30 days of issue of purchase order.
- 19. PBG:** In case, successful tenderer wishes to furnish security deposit in the form of Performance Bank Guarantee of value equal to Security Deposit, the same should be submitted within 30 days of issue of purchase order, failing which a penalty interest of 15% per annum shall be charged for the delay period i.e., beyond 30 (thirty) days from the date of issue of LOA/PO. This PBG should be from a Scheduled Bank and should cover **warranty period plus three months** for lodging the claim. The performance security Bond will be discharged by the Purchaser after completion of the supplier’s performance obligations including any warranty obligations under the contract. PBG format specified in FORM – IV

Note: A separate advice of the BG will invariably be sent by the BG issuing bank to the RailTel’s Bank through SFMS (**MT 760**) and only after this the BG will become acceptable to RailTel. It is therefore in own interest of bidder to obtain RailTel’s bank IFSC code, its branch and address and advise these particulars to the BG issuing bank and request them to send advice of BG through SFMS to the RailTel’s Bank.

20. Payment Terms:

90% of the value of the part supply of the equipment/material on receipt by the consignee at site duly inspected and accompanied with the following documents and any other documents mentioned in the contract:-

- i) Invoice
- ii) Delivery Challan
- iii) contractor certificate of dispatch
- iv) Inspection certificate
- v) Consignee receipt
- vi) Warranty guarantee certificate of OEM
- vii) Insurance certificate
- viii) Undertaking against Fall Clause
- ix) OEM certificate that material supplied is as per specification/the quantity material supplied is as per SOR.

Balance **10%** value of supply on receipt and acceptance of full PO quantity at site by consignee.

OR

100% payment may be made on receipt of documents stated above in accordance with the accepted conditions provided that an additional Bank Guarantee for an amount equivalent to 10% of the value of the supplied valid for a period of six months is furnished by the supplier with the undertaking that the stores supplied shall be free from damages/shortages. In those cases, where such damages/shortages are intimated to the supplier in writing, the bank guarantee shall be extended without fail by the supplier for a suitable period at the request of purchaser in writing. Failure to do so shall result in forfeiture of Bank Guarantee. The bank guarantee will be released only after the cases are settled in accordance with the provisions of document.

21. Bill Passing & Paying Authority: Bill passing Authority is respective Territory Managers (TM) and bill paying Authority is DGM/Fin/SR/SC. **Bills to be submitted to respective Territory Managers (TM) for processing.**

Secunderabad (SC) - Bill passing authority is JGM/TM/SC and BZA and bill paying authority is DGM/Fin/SC.

Andhra Pradesh (BZA) - Bill passing authority is JGM/TM/SC and BZA and bill paying authority is DGM/Fin/SC.

Karnataka (SBC) - Bill passing authority is JGM/SBC and bill paying authority is DGM/Fin/SC.

Tamil Nadu (MAS) - Bill passing authority is GM/MAS and bill paying authority is DGM/Fin/SC.

Kerala (ERS) - Bill passing authority is JGM/ERS and bill paying authority is DGM/Fin/SC

22. Notarized Affidavit: The tenderer shall submit a notarized affidavit on a non-judicial stamp paper stating that they are not liable to be disqualified and all their statement/documents submitted along with bid are true and factual. Standard format of the affidavit to be submitted by the bidder is enclosed as **Form-V. Non submission of an affidavit by the bidder shall result in summarily rejection of his/their bid.** And it shall be mandatorily incumbent upon the tenderer to identify state and submit the supporting **documents duly self-attested** by which they/he is qualifying the Qualifying Criteria mentioned in the Tender Document. It will not be obligatory on the part of Tender Committee to scrutinize beyond the submitted document of tenderer as far as his qualification for the tender is concerned.

The RailTel (RCIL) reserves the right to verify all statements, information and documents submitted by the bidder in his tender offer, and the bidder shall, when so required by the RailTel (RCIL), make available all such information, evidence and documents as may be necessary for such verification. Any such verification or lack of such verification by the RailTel (RCIL) shall not relieve the bidder of its obligations or liabilities hereunder nor will it affect any rights of the Railtel/Railway there under.

In case of any wrong information submitted by tenderer, the contract shall be terminated. Performance Guarantee (PG) of contract forfeited and agency barred for doing business on RailTel (RCIL) for 3years.

23. Online Submissions: The bidder is required to upload and submit the following documents on line before due date & time of tender. The due date & time for closing of the bid as per tender NIT and the bid will be opened as per tender NIT.

- ii) Clause wise compliance along with all mentioned documents/Forms for all clauses of Tender.
- iii) Data Sheet of offered item/equipment.
- iv) Financial (Certified copies of audited balance sheets/annual reports of last three preceding financial years) and Technical Eligibility Criteria documents.
- v) Technical Compliance of all Specification of items as per Tender document.
- vi) Proof of document required against Eligibility criteria of OEM (or) Authorized bidder of OEM.
- vii) Statement of deviation as per Form-II
- viii) MAF/OEM Authorization as per Form-III
- ix) Notarized affidavit on a non-judicial stamp paper as per Form-V

24. Offline documents: Original copy of documents shall be submitted by tenderer offline at RailTel Corporation of India Ltd., 6A, 6th Floor, Gumidelli Towers, Opp: Shoppers Stop, Begumpet – 500016 at any point of time whenever asked for verification.

25. Insurance:

- i. The Contractor shall take out and keep in force a policy or policies of insurance from the date, the delivery of material starts (including the transit portion) against all liabilities of the contractor or the Purchaser. The contractor shall take out and keep in force a Policy or policies of Insurance for all materials covered in schedule of requirement irrespective of whether used up in the portion of work already done or kept for the use in the balance portion of the work until such material are provisionally handed over to RailTel. The contractor should ensure the stores brought to site, against risks as required under the Emergency Risk (Goods) Insurance Act in force from time to time up to contract value.
- ii. It may be noted that the beneficiary of the insurance policy should be RailTel, or the policies should be pledged in favour of RailTel. The contractor shall keep the policy/policies current till the item/equipment are handed over to the purchaser and I&C of the same.

26. Constitution of Firm and Power of Attorney:

1. Any individual(s) signing the tender or other documents connected therewith should specify whether he is signing: -
 - (a) As sole proprietor of the concern or as attorney of the sole Proprietor.
 - (b) As partner or partners of the firm.
 - (c) As a Director, Manager or Secretary in the case of Limited Company duly authorized by a resolution passed by Board of Directors or in pursuance of the authority conferred by Memorandum of Association.
2. In the case of a firm not registered under the Indian Partnership Act, all the partners or the attorney duly authorized by all of them should sign the tender and all connected documents. The original Power of Attorney or other documents empowering the individual or individuals to sign should be furnished to the Purchaser for verification, if required.
3. The RailTel will not be bound by Power of Attorney granted by the tenderer or by the changes in the composition of the firm made subsequent to the execution of the contract agreement.
4. In case where Power of Attorney partnership deed has not been executed in English, the true and authenticated of copies of the translation of the same by Advocate, authorized translators of Courts and licensed Petition Writers should be supplied by the contractor(s), while tendering of the work.
5. The duly notarized Power of Attorney shall be submitted in original at the time of bid submission as per clause above.

Note:

- 1) The bidder is required to give acceptance of all the clauses of Tender document. Any deviation / non-acceptance may lead to rejection of the bid.
- 2) Information to Bidder viz. corrigendum /addendum/ amendments etc. for this bid shall be posted on www.railtelindia.com and <https://railtel.enivida.com> only.

- 3) After opening of the technical bid no correspondence/submission of document made at the initiative of the bidder will be entertained. However, the purchaser can, if required, ask for clarifications which need to be submitted before a target date. The clarifications submitted as required by the purchaser before the target date will be considered.

27. DENIAL CLAUSE - Supplier will not be entitled to any benefit of upward statutory variations in GST rates Announced after expiry of the original Delivery Period as per purchase order & in Case of reduction in GST rates if any, benefit will be passed on to RailTel at any stage of the contract.

28. Liquidated damages - Liquidated damages @0.5% per week or part thereof (with a maximum ceiling of 10% of the order value), shall be applicable if the delivery is not affected within the stipulated deliver period/completion period.

29. Acceptance of the Offers: The RailTel is not bound to accept the lowest or any offer and reserve to itself the right to accept any offer in respect of the whole or any portion of the item specified in the tender and contractor shall be required to supply at the rate quoted.

30. Quantity to be ordered:

As per SOR. However, RailTel reserves the right to cancel the tender for full or part quantity tendered without assigning any reason.

31. Variation of quantity: The purchaser reserves the right to increase and /or decrease the order quantity by a quantity not exceeding 30% of the ordered quantity on the same price and terms and conditions during the currency of the contract, with suitable delivery schedule for the enhanced quantity.

32. Quotations for Imported items: -

1.1 Imported Stores offered by Indian Agents in Indian Currency: Any authorized dealer / agent / recognized industrial distributor quoting on behalf of their foreign principal in Indian Rupees shall have to comply with the following: -

- a) To quote with tender specific authorization from the foreign manufacturer.
- b) (i) While quoting on behalf of foreign principals' tenderers are required to furnish the principal's invoice / Performa invoice along with their quotation.
(ii) Performa invoices, however, may be accepted in exceptional cases where it is not possible to obtain the invoices before the contract is placed.
- c) The tenderer shall have to undertake in the tender to comply with the following:
 - i) Consent to furnish copy of customs out passed bill of entry for the goods, relevant to each consignment, Manufacturer's Test and Guarantee certificate issued by the manufacturer, Copy of Bill of Lading/AWB relevant to the consignment; Copy of commercial invoice of the foreign manufacturer/principals relevant to each consignment.
 - ii) Current and valid authorization/dealership certificate of foreign manufacturer/ principal.
 - iii) Compliance of sea/air worthy packing condition in manufacturer's original packing with manufacturer's tamper proof seal and compliance of the Packing condition as laid down in Standard Conditions of Contract.

1.2 Time for and Date of Delivery; the Essence of the Contract:

The time for and the date specified in the contract or as extended for the delivery of the stores shall be deemed to be of the essence of the contract and delivery must be completed not later than the date(s) so specified or extended.

Failure to comply with any of the aforesaid conditions as referred to above will make the offer liable to be rejected.

1.3 Tenderer has to indicate the following while submitting the offer:

- a) The precise relationship between foreign manufacturer/principal & their agents/ associates.

- b) The mutual interest which the manufacturer/principal and the Indian agent / associates have in business of each other is to be indicated.
- c) Indian agent's Permanent Account Number is to be indicated.

33. Terms of Delivery:

- a) Mode of dispatch should be by road / reputed courier / in person through the authorized representative of the Tenderer.
- b) Tenderer shall submit the offer clearly on CIP destination basis.
- c) Transit Insurance for risk in transit should be arranged by the supplier since risk in transport in all such cases rests with the supplier.

34. Delivery Schedule

- a) The tenderer should note the required delivery schedule of RailTel given in the tender schedule /offer form and quote accordingly. Vague Delivery terms must be avoided and if quoted will be taken as commercially unresponsive to RailTel's requirement.
- b) Time for and the Date of delivery as specified in tender schedule /offer form is the essence of the Contract. However, extension of Delivery date may be considered in deserving cases where genuine reasons exist. Such extensions of delivery date may be considered with or without Liquidated damages and Denial Clause as per Standard conditions of Contract.
- c) Recover from the Contractor as agreed liquidated damages and not by way of penalty a sum equivalent to half per cent of the price of any stores (including elements of taxes, duties, freight, etc.) which the Contractor has failed to deliver within the period fixed for delivery in the contract as extended for each week or part of a week during which the delivery of such stores may be in arrears where delivery thereof is accepted after expiry of the aforesaid period The upper limit for recovery of liquidated damages will be 10% (Ten Percent) of Total contract value provided in the contract.

35. Marking of Material Supplied:

The tenderer should agree to indicate the Buyer Company Name, Manufacture's Name, Month and Year of manufacturing by casting/stamping/etching/embossing, at an appropriate place of each piece supplied, without affecting the functional utility and structural stability of the components/material.

36. Procurement from Manufacturers Authorized agents / Distributors:

Only Manufacturers or their authorized Agents/ distributors need to quote with tender specific authorization from the manufacturers failing which offers are liable to be ignored. Where a manufacturer appoints an agent or a distributor on the basis of a written agreement with him for a specific territory or specific set of items, he shall give an undertaking to the following effect.

- a) Direct dispatch from the premises of the manufacturer to the consignee.
- b) Submission of manufacturer's Test and Guarantee Certificate (MTGC) with each lot of supplies.

37. Purchaser's right to accept any Bid and to reject any or all Bids:

The Purchaser reserves the right to accept or reject any bid, to annul the process at any time prior to award of contract and without thereby incurring any liability to the affected bidder or bidders on the grounds of the Purchaser's action.

38. Issue of Confirmed Supply Orders:

RailTel will issue the Supply Orders within validity period of contract Agreement/Advance Purchase order.

39.
