The service provider should produce satisfactory work completion certificate of at least one similar single work (providing similar manpower services), for a minimum value of 35% of Advertised Value of Work in the last 3 financial years (2017-18, 2018-19& 2019-20)
- II. The service provider should have received total contract amount of at least 150% of the advertised Value of Work during the last 3 financial years (2017-18, 2018-19 & 2019-20)).
