(RailTel), Eastern Region on behalf of East Central Railway invites Open e- Bids in two packet single stage system from established contractors with proven experience for the work of "Rectification of underground Optical fibre cable in (a) Mainaguri - Y Leg, (b) New Mal - Changrabandha (c) New Coochbihar - Changrabandha, (d) New Coochbihar - Alipurduar Sections of North East Frontier Railway by trenching, laying of HDPE duct, backfilling, blowing/pulling, Splicing/jointing, termination & testing of OFC with associated work for RailTel Corporation of India Limited, Eastern Region."
