Eligibility Criteria:

The tenderer must have successfully completed any of the following during last 07 (seven) years, ending last day of month previous to the one in which tender is invited:

- i. Three similar works each costing not less than the amount equal to 30% of advertised value of the tender, or
- ii. Two similar works each costing not less than the amount equal to 40% of advertised value of the tender, or
- iii. One similar work each costing not less than the amount equal to 60% of advertised value of the tender, or

Should have performed OFC route maintenance for a continuous stretch of more than 150kms for a minimum period of 3 months in the past three financial years including current year before the date of opening of tender.

The tenderer must have received contractual payments in the previous three financial years and the current financial year up to the date of inviting of tender, at least 150% of the advertised value of the tender (2020-21, 2021-22, 2022-23 & 2023-24 respectively). The Tenderers shall submit Certificates to this effect i.e. Audited Balance Sheet along with P&L A/c duly certified by the Chartered Accountant/Certificate from Chartered Accountant duly supported by Audited Balance Sheet, P&L a/c.
