Eligibility Criteria:

Tenderer must have completed successfully and satisfactorily at least one single similar work costing not less than 35 % of the advertised tender value of work during the preceding three financial years (i.e. current financial year and three previous financial years) executed for Govt. /PSUs of State/Central. **Offers not accompanied by copies of POs and work completion certificate (users in the format of Form no.2) will not be considered.**

The total contract amount received by the tenderer during the last three years as per Audited balance sheet should be a minimum of 150% of advertised Tender Value of work. **Offers not accompanied by Audited balance sheet will not be considered.**

Firms registered with NSIC or any other body specified by Ministry of MSME having UDYAM certification for the tendered item / work is exempted from submission of cost of tender. Firms claiming for the above exemptions under UDYAM certification have to submit supporting documents as per clause no 5.6.1 of instructions to tenderers, Section II Chapter-1 without which their offers will be considered as invalid and summarily rejected.
