(RailTel), Eastern Region on behalf of East Central Railway invites Open e- Bids in two packet single stage system from established contractors with proven experience for the work of "Rectification of underground Optical fibre cable in Mansi - Saharsa - Purnea Section of East Central Railway by trenching, laying of HDPE duct, backfilling, blowing/pulling, Splicing/jointing, termination & testing of OFC with associated work for RailTel Corporation of India Limited, Eastern Region."
