With reference to your email dated 9th March 2026 regarding news item appeared in the "https://www.thehindubusinessline.com/" dated 09th March, 2026 captioned "GAIL signs MoU with RailTel to build digital infrastructure backbone. In this regard, we would like to submit our response, as follows:

1	Whether such negotiations were taking place? If so, you are advised to provide the said information along with the sequence of events in chronological order from the start of negotiations till date.	Yes, the RailTel has entered into a Memorandum of Understanding (MoU) with GAIL on 5 th March 2026 for building a digital infrastructure backbone. However, at this stage, no definitive terms have been finalized. The Company would like to clarify that the said MoU is non-binding in nature and does not qualify as a material event under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI LODR"). Further, the movement in the Company's share price during the day seems no connection with the aforesaid news item and may be attributed to the prevailing general market conditions.
2	Whether you/company are aware of any information that has not been announced to the Exchanges which could explain the aforesaid movement in the trading?	The Company confirms that it is not aware of any material information or event that has not been disclosed to the Stock Exchanges under Regulation 30 of the SEBI LODR, which could have a bearing on the price / volume movement in the Company's shares. The Company has been making timely disclosures of all material events / information as required under applicable regulations.
